#### Crime and Enforcement Update

On October 15, at 1:38 p.m., Bayview's Officer Lavin, who focuses on quality of life offenses, was checking the area of Wallace and Hawes following a very large clean-up of the area by numerous city agencies. This area has been used as an illegal dump site (and stolen auto strip site) for several years. Officer Lavin found a container covered with tarps which had been dragged onto the site, and found a man living inside the container. The man had an outstanding warrant for his arrest and was arrested, and once at Bayview Station, it was determined that the man was a convicted sex offender who had failed to properly register. He was charged with failing to register as a sex offender, in addition to the warrant charges (041 180 556).

On October 16, at 9:45 a.m., Bayview plainclothes officers were on patrol on the 700 block of Missouri when they saw two men, known to them as Zoo Block gang members, loitering on the block. The officers knew that one of the men, who is currently on parole, is prohibited under his parole conditions, and a separate court-issued stay away order, from being present on the 700 block of Missouri Street. The officers detained the man and contacted his parole agent, who verified not only that he was prohibited from being in the Zoo Block gang territory, but that he had missed his latest parole meeting. The man was booked for violation of his parole (041 183 447).

On October 16, at 10:30 a.m., Bayview officers were on patrol at Napoleon and Evans when they saw a large collection of tents, shopping carts, and garbage strewn about the street. The officers advised the persons present to clean up the site, and a woman present was arrested for an outstanding narcotics arrest warrant (020 040 600).

On October 16, at 1:49 p.m., Bayview officers responded to Baldwin Court on the report of a fight involving a gun. Upon arrival the officers met with a man who stated that he had been involved in a physical fight with his roommate, but that no gun was involved. The officers found the roommate, and although both parties had minor injuries, no guns were involved and

neither party wished police action. The officers determined that the first man had both an outstanding arrest warrant, and a court-issued stay away order prohibiting him from being in the area. The man, living on Griffith, was booked accordingly (041 184 279).

On October 16, at 2:17 p.m., Bayview plainclothes officers were on patrol at Harbor and Northridge when they saw what appeared to be a drug transaction. One of the men was holding several baggies of marijuana and displaying them to the second man. The first man, a juvenile living on Northridge, was booked for possession for sale of marijuana, as well as for an outstanding arrest warrant from Solano County. The second man was booked for an outstanding arrest warrant from Marin County (041 184 310).

On October 16, at 4:41 p.m., Bayview officers were on patrol on the 1600 block of LaSalle when they saw a man urinating on the street and stopped to issue him a citation. The officers determined that the man was wanted for an outstanding warrant charging him with sales of cocaine and possession for sale of cocaine. The man, living on Golden Gate Avenue, was booked for the warrant (041 184 865).

On October 16, at 4:45 p.m., Bayview plainclothes officers were on patrol at 3rd and Quesada when they saw two young men loitering on the front steps of a home on the 1600 block of Quesada. The officers contacted the two men and noticed that a vehicle parked nearby had one of its rear windows broken out. The officers checked the vehicle and saw several bags of marijuana inside. The officers retrieved the marijuana and found two loaded handguns under the vehicle's front seat. The guns and marijuana were seized, and the officers found personal papers and other identification in the vehicle tying the vehicle to the detained subjects, who were both arrested. The first young man, 18 years old and living on Latona Street, was booked for various weapons charges and possession of marijuana. The second young man, a juvenile living in Pacifica, was booked at YGC for the same charges (041 184 730).

On October 16, at 5:30 p.m., Bayview officers responded to Klein's Deli at 501 Connecticut Street on the report of an assault. The employees told officers that a male and female suspect had walked into the deli and, as the male distracted the employees by ordering food, the female grabbed the tip jar and ran from the premises. The male stayed behind and then complained about the food he had received, and an employee chased the female but lost her. The male is described as a black male, 5'4", 130, wearing a red, white and blue cap, a blue hooded jacket and blue jeans. The female is described as a black female, 15-17, 5'5", 115, long braided hair, wearing a p-coat and blue denim jeans (041 185 108).

On October 16, at 8:26 p.m., Bayview officers were on patrol at Phelps and Egbert when they saw a man drive by and recognized him as being wanted for a domestic violence incident involving a handgun which had occurred two days prior. The officers detained the man to inquire about the prior incident, and he provided a fictitious name. The officers brought the man to Bayview Station, where he was correctly identified via his fingerprints, and he was charged with the prior domestic violence case. The man was also charged with possession for sale of marijuana due to the marijuana located

in his vehicle (041 185 647).

On October 16, at 8:43 p.m., Bayview officers responded to a home on the 1500 block of Van Dyke on a domestic violence call. The officers interviewed the child caller who stated that his father was intoxicated and had struck his mother when she took his car keys away from him. The man, who had been drinking earlier at a bar, had left his vehicle at the bar, and when he went to leave the house to retrieve the vehicle, his wife had taken his keys. The man was booked for domestic violence (041 185 584).

On October 17, at 3:08 p.m., Bayview officers responded to Ingalls and Harbor on the report of an injury accident. The officers found a severely damaged vehicle up against a tree and a victim being treated for a head wound. A second victim, an 11 year old boy, had already been transported from the scene. The boy's arm had been severed in the accident. Several witnesses at the scene told officers they had seen the driver fleeing the area on foot following the accident. The witnesses also stated that the driver had been "driving crazy" in the area all day. The officers eventually located the driver, who is on federal probation for armed robbery, and arrested him for felony hit and run and felony drunk driving (041 188 083).

On October 17, at 4:30 p.m., Bayview officers were on patrol at Westpoint and Middlepoint when they saw a woman drinking an "open container" of alcohol and stopped to cite her. The officers attempted to obtain the woman's name, but she was very evasive and began to walk away, stating that she had to "go to the bathroom." The woman then dropped her pants and "went to the bathroom." The woman provided the officers with her name, which proved to be fictitious, and the officers attempted to place her under arrest. The woman began to struggle violently, kicking both the officers and their vehicle, and attempting to kick out the vehicle's windows. The woman, living on Westpoint Road, was eventually booked for a variety of charges (041 188 497).

On October 17, at 8:25 p.m., Bayview officers were on patrol at 3rd and Jerrold Streets when they were flagged down by a woman who told the officers she had just been robbed. The woman pointed inside the KFC Restaurant and identified the man who had robbed her. The officers entered the restaurant and approached the man, who immediately became hostile and attempted to walk away from the officers. After several minutes of struggling with the man, the officers were eventually able to bring the man under control. The victim then told the officers that she had been at the bus stop at 3rd and Jerrold when the suspect had approached her and demanded money. The suspect then removed currency from the victim's hand and struck her. The suspect then told the victim, "If you say anything about this, I'm going to (expletive deleted) you up." The suspect, living on Visitacion Street, was booked at Bayview Station for robbery, resisting arrest, and threatening a peace officer. While at Bayview, the suspect threatened to "finish" the arresting officer the next time he saw him (041 188 914).

On October 17, at 10:12 p.m., Bayview officers responded to the first block of Dakota Street on the report of a residential robbery. The victim told the officers that three armed gunmen wearing ski masks had forced their way

into his apartment and ordered him to lie on the floor. The suspects then stole the victim's currency and his gold teeth. Two additional adult victims were present in the apartment at the time of the robbery, and they were each robbed of their property as well. The suspects are described as black males wearing dark clothing and ski masks (041 189 291).
