

The Police Commission of the City and County of San Francisco met in Room 400, City Hall, #1 Dr. Carlton B. Goodlett Place, San Francisco, at 5:45 p.m., in a Regular Meeting.

Commissioner Sparks welcomed newly-sworn in Commissioner David Onek. Commissioner Onek introduced himself and gave a brief background about himself.

**PUBLIC COMMENT**

Barry Tarranto, taxicab driver, commended Sergeant Reynolds for his work with the taxi industry and discussed concerns regarding enforcement of laws against illegal limousines and taxis.

**REPORTS TO THE COMMISSION**

Chief Fong started with highlighting some of the good work by members of the Department. Chief Fong also talked about the violence prevention plan.

Commissioner Sparks asked for a PDF format of the violence prevention plan.

Commissioner Campos would like to know what the department's policy in regards to the Sanctuary City statute.

Commissioner Sparks asked for a presentation with interested groups in regards to the sanctuary statute relative to what's been in the newspapers in regards to immigration issues.

Deputy Chief Keohane addressed the Commission and introduced Lt. Greg Yee and Ms. Jeanne Chisholm to present the update on Neighborhood Crime Mapping Project.

Commissioner Sparks commended the Department on work done on this project and asked that the crime mapping link on the police website be more prominent. She also stated that maybe a press release be put out so that the public is aware that the department is responsive to the public's need.

Deputy Chief Keohane stated that it is always good to have more personnel and that these positions are already on the budget. He also stated that they are currently looking to replace the CIO position and will be interviewing candidates soon.

Commissioner Lee stated that it would be good to get this information to the LEP community and asked that the Department to talk to Mr. Ed Lee, City Administrator, to get the information out to the LEP community.

Commissioner Mazzucco asked how accessible is the information to the officers working in district stations. Lieutenant Yee stated that it is not

accessible to district stations due to lack of internet access. Commissioner Mazzucco asked how hard is it to get computers and internet access for the officers at the stations. Lieutenant Yee stated that he has limited personnel and that if he is asked to change the priority to internet access to the stations then that would be the priority. Chief Fong stated that it is important to have internet access for all the stations but for now, printing out the information on a daily basis so that officers can have a copy before their shift starts can be done and ultimately internet access will be discussed.

Commissioner Lee asked if volunteers can be help in providing immediate internet access to the district stations. Lieutenant Yee stated he will discuss that with Deputy Chief Keohane.

Commander Murphy presented the update regarding implementation of recommendations of the Foot Patrol Study.

Commissioner Sparks how are the number, locations, and hours of foot beats compare to that which was originally designated before the pilot program period. Commander Murphy stated that it will be fairly consistent as far as locations and times of the beats. He also stated that once all input and information are gathered, the map will be rewritten. Commissioner Sparks stated that once Commander Murphy has all the foot beats, she would like a comparison report as to number of hours by district, number of hours and location of beats prior to the pilot program.

Commissioner Lee asked about cultural competency training for foot beat officers. Commander Murphy stated that training for the foot beat officers come from a variety of resources like SAFE, Mons, District Attorney's Office, City Attorney's Office and community members.

Director Joyce Hicks reported on three items (1) Performance Plan and Appraisal Report, (2) hiring 8124 Investigators, and (3) 2008 Second Quarter Report. Ms. Hicks asked that a commissioner meet with her to discuss her proposed performance plan. Commissioner Sparks stated that she has asked Commissioner DeJesus to discuss the plan with Director Hicks. Director Hicks also stated that she will be presenting the 2008 Second Quarter report on August 6<sup>th</sup>.

Commissioner Marshall thanked the Chief and the Command Staff for their support during the press conference and in putting the crime prevention plan together.

Unidentified apologized to the Chief for what he said at last week's meeting and thanked the Commission and the Department.

Commissioner Sparks asked that individual speakers not to identify individual involved in this matter.

Captain Corrales stated that the officer in question was partner to Officer Jon Cook who died in the line of duty. Captain Corrales stated that less than two months later, the officer was back to work and was forced to use deadly force on a suspect. Captain Corrales stated that this officer is an excellent officer. He asked that the officer be given one last chance.

Captain Jimenez concurred with Captain Corrales and spoke on behalf of the officer involved. He spoke of the officer's dedication to the city and the department.

Lieutenant Militello stated that she believes that the department has failed the officer involved and that the department has not done enough for this officer. Lieutenant Militello stated that the officer involved is one of her hardest working officer in her platoon and asked the Commission to give the officer one last opportunity.
