

The Police Commission of the City and County of San Francisco met in the Northern District, at the African American Art & Culture Complex, 762 Fulton Street, San Francisco, at 6:00 p.m., in a Regular Meeting.

PRESENT: Commissioners Marshall Mazzucco, DeJesus, Hammer, Onek, Pan

ABSENT: Commissioner Lee

Commissioner Marshall welcomed the audience and asked the Commissioners to introduce themselves.

**REPORTS TO THE COMMISSION**

**a. Chief's Report**

**- Update on significant policing efforts by Department members**

Chief Gascón gave a brief report on crime stats and discussed a meeting with the Board of Supervisors in regards to the public safety bond measure.

Commissioner Hammer would like an update in regards to backlog in DNA cases.

Commissioner DeJesus asked about the recent officer-involved shooting. Chief Gascón stated that the officers were not told there was a weapon. The officers were told that there were no weapons in the household. The officers did not have a bean bag weapon and that a bean bag weapon would not have been the appropriate weapon due to the closed proximity. The Chief then continued to explain what happened during the incident.

Frank Canada discussed concerns regarding the sit and lie ordinance.

**CAPTAIN ANN MANNIX, COMMANDING OFFICER OF NORTHERN STATION, TO ADDRESS THE COMMISSION ON POLICE ACTIVITIES IN THE NORTHERN DISTRICT**

Captain Mannix described the demographics of Northern Station and discussed police activities in the district. Captain Mannix also recognized Sergeant Marty Lalor for his great work in the Department.

## **PUBLIC COMMENT**

Linda Chapman, Nob Hill resident, discussed concerns regarding prostitution and the different crimes that go with it. Ms. Chapman also discussed the sit and lie ordinance.

Dr. John Dorsey discussed the need for officers training to understand mental health issues in the African-American community.

Bud Hazelton, Cab Driver Coalition, discussed concerns regarding the staffing of a cab driver and the disbanding of the taxi detail.

Dawn Trenor, Middle Polk Neighborhood Association, commended Captain Mannix as well as the captain of Central Station and discussed crimes committed by commuters from outside of San Francisco.

Commissioner Mazucco asked about the inspectors move to the station. Lieutenant Plyer stated that he does not have specific numbers but thinks that it is working out great.

Commissioner DeJesus asked about homeless outreach. Captain Mannix explained that generally the community can email her and that the officers are all asked to do homeless outreach.

Commissioner Pan asked about getting information out to the communities. Captain Mannix stated that there is a weekly newsletter which includes safety tips and community alerts are also put out.

Commissioner Marshall congratulated the community and the department for keeping crime rates low in the district.
